- The final budget includes the approved final budget for the NeoCity Property Owners Association. The Property Owners Association approved a final Fiscal Year 2025-2026 budget of \$509,124 on June 2, 2025 meeting.
- The District's final Fiscal Year 2025-2026 budget is \$549,627. The special assessments fees will be the primary revenue source for the District when imposed.
- The tentative special assessment rate is \$105.71.

#### **RESOLUTION NO. 25-003R**

A RESOLUTION OF THE NEOCITY IMPROVEMENT DISTRICT, FLORIDA APPROVING THE FINAL BUDGET FOR 2025-2026 FISCAL YEAR; PROVIDING FOR CONFLICTS AND SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board desires to adopt a budget for the 2025-2026 fiscal year as described in Section 189.16, Florida Statutes.

WHEREAS, the NeoCity Property Owners Association adopted a final budget for the 2025-2026 fiscal year on June 2, 2025.

NOW THEREFORE, BE IT RESOLVED BY THE NEOCITY IMPROVEMENT DISTRICT, FLORIDA;

**SECTION 1.** ADOPTION OF RECOMMENDED BUDGET. The final NeoCity Improvement District budget for Fiscal Year 2025-2026, totaling \$549,627.00 summarized by fund and revenue/expense category in Schedule A, is hereby approved and adopted. There are hereby appropriated out of anticipated revenues and balances brought forward, all funds and monies necessary to meet the appropriations and reserves stipulated by and in said recommended budget.

SECTION 2. CONFLICTS AND SEVERABILITY. All sections or parts of section of all resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict. If any section, subsection, sentence, clause, or provisions of this Resolution is held unconstitutional, inoperative, or void by a court of competent jurisdiction, such holding shall not affect the remainder of the Resolution.

**SECTION 3. EFFECTIVE DATE.** This Resolution shall take effect immediately upon its adoption.
